

Official Rules – International Credit Union Day 2021 Cash Giveaway University of Louisiana Federal Credit Union

1. No purchase is necessary to enter or win.

2. Eligibility for Promotion: All University of Louisiana Federal Credit Union ("Credit Union") members in good standing (as determined by Sponsor in its sole discretion), who are 18 years or older, and legal residents of the United States as of the date of their entry and prize award drawing.

3. Promotion Period: Begins at 9:00:00AM Central Time (CT) on Monday, October 18, 2021 and ends at 5:00:00PM CT on Friday, October 22, 2021.

4. To Enter: Complete an entry form by visiting a University of Louisiana Federal Credit Union branch lobby during the Promotion Period. Limit one entry per person during the Promotion Period. Other restrictions and exclusions may apply.

5. All other entries ("manual entry") will be entered in the drawing upon receipt of a mailed written entry on a 3 x 5 piece of paper setting forth the member's name, account number, address, and telephone number and mail in an envelope to University of Louisiana Federal Credit Union, ICU Day Giveaway, P.O. Box 43635, Lafayette, LA, 70504. Entries must be postmarked no later than Friday, October 22, 2021. One entry per envelope for entries that are not automatic; no photocopied or mechanically reproduced entries accepted; and the Credit Union is not responsible for lost, late, misdelivered, illegible, incomplete or postage-due entries. One manual entry per member during the entire promotion. Entries become the property of University of Louisiana Federal Credit Union and will not be returned.

6. Drawing: One prize drawing will be held no later than Friday, October 22, 2021. A total of three (3) winners will be randomly selected from all eligible entries. There are multiple prizes available to be won, as follows: (1) \$100 cash, (1) \$50 cash and (1) \$25 cash. Winners need not be present to win. Winner(s) may not exchange prize for another. No entrant may win more than one (1) prize, regardless of the number of entries submitted. Only winners of the drawing will be notified by phone and/or mail. The Credit Union is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winner(s). If a selected winner cannot be contacted by phone and/or mail provided on the entry within 2 days of drawing, prize may be awarded to another randomly selected winner.

7. Entrant Agreement: Participation in drawing constitutes full and unconditional agreement to, and acceptance, of these Official Rules. Prize will be awarded only if entrant complies with these Official Rules.

8. Eligibility Exceptions and General Terms: Employees of the Credit Union, members of the Board of Directors and volunteer officials, and their immediate family members are not eligible. Sweepstakes void where prohibited by law. All federal, state and local laws and regulations apply. No cash or other consideration will be paid and winners are responsible for any applicable taxes or other expenses related to any prize awarded.

9. Consumer Disclosure: Odds of winning dependent upon the number of eligible entries received versus the number of eligible participants. The Credit Union will award prizes totaling \$175.00 (see Drawing).

10. Release of Claims: The winner, members of the winner's household, relatives and persons who use any prize awarded by University of Louisiana Federal Credit Union, and such persons heirs, assigns, executors, and administrators release and exempt University of Louisiana Federal Credit Union and its directors, officers, employees and agents from any and all claims, actions, demands, and damages which they have now or any time in the future arising from use of any prize, including personal injury or death.

11. Publicity: By accepting a prize, winner consents to the use of his/her name and photograph or likeness for advertising and promotional services without additional compensation. The winner's name and/or likeness can be used by the Credit Union in any news release, advertisement or other Credit Union communications without further compensation or consideration, the prize awarded being deemed sufficient consideration for all terms and conditions. The Credit Union may copyright and use, reuse, publish and republish the winner's picture, portrait or other likeness, character, characterization or form with the winner's name in any media for any reasonable purpose, including any printed matter prepared by/for or distributed by/for the Credit Union without any prize winner inspection or approval of any publication, advertisement, copy or other printed matter or its use by or for the Credit Union. The winner releases any liability, claims, actions, demands, and damages relating to any publication, distortion, blurring, alteration, optical illusion, or use in composite form or otherwise that may occur or be produced intentionally or otherwise, even should this subject the winner to ridicule, scandal, reproach, scorn or indignity.

12. Winner(s) Listing: The prize winner(s) may be posted at Credit Union branches or may be published in a future issue of the Credit Union's newsletter.
